Craig J. Della Valle, MD

Dr. Craig J. Della Valle is a native of New York and received his undergraduate and medical degrees from the University of Pennsylvania in Philadelphia. He completed his residency at the Hospital for Joint Diseases in New York City. During his residency he spent a full year devoted to clinical and basic science research in the field of adult reconstructive surgery. Dr. Della Valle completed a

fellowship in adult reconstructive surgery at Rush University Medical Center and Central DuPage Hospital.

He is presently the Aaron G. Rosenberg endowed professor of orthopaedic surgery and chief of the section of adult reconstruction at Rush University Medical Center in Chicago, Illinois.

Dr. Della Valle specializes in primary and revision total joint arthroplasty and has done more than 15,000 hip and knee replacements. A respected researcher, he has more than 300 peer-reviewed publications on topics including unicompartmental, primary, and revision total knee arthroplasty as well as total hip arthroplasty, hip resurfacing, and revision total hip arthroplasty.

Dr. Della Valle is a member of The Hip Society, The Knee Society and The International Hip Society. He is also a past president of the American Association of Hip and Knee Surgeons, past president of the Mid-America Orthopaedic Association and is in the presidential line for The Knee Society.

G. Douglas Letson, MD

Dr. G. Douglas Letson is executive vice president of clinical affairs and physician-in-chief at Moffitt Cancer Center, as well as prior chair of the Sarcoma Department. In addition, he is a professor of surgery, radiology, and orthopaedics at the University of South Florida.

As an orthopaedic oncology surgeon, Dr. Letson's research and clinical interests include: novel therapeutic agents to treat sarcoma; limb salvage for bone and soft tissue tumors; segmental prosthesis; new hinge designs; and soft tissue attachment for metallic prosthesis. He has a keen interest in new techniques and design of instrumentation for minimal invasive reconstructive surgery. He collaborated with Stanmore Corporation in England to develop a non-invasive leg lengthening implant and is the only physician in the United States to implant and lengthen the limbs of several children successfully.

A graduate of Louisiana State University (LSU) School of Medicine, Dr. Letson completed his residency in orthopaedics at LSU-affiliated hospitals and he was chief resident at LSU Children's Hospital. He pursued advanced training through a musculoskeletal oncology fellowship at Massachusetts General Hospital-Harvard Medical School and was awarded Clinical Oncology Fellow of the American Cancer Society.

As a leader in medical education, he is a frequent guest speaker at local and international physician conferences teaching annual musculoskeletal oncology review courses in Oxford, England, Venice, Italy, and Hong Kong. He has started multiple educational courses worldwide in medical education and is also the founder of the Florida Keys Musculoskeletal Oncology review course which is now in its 20th year.

Dr. Letson has received numerous awards, including American Orthopaedic Academy Honor Society, Professor of the Year at Orlando Regional Healthcare, Teacher of the Year for the USF Radiology Department, and Best Doctors in America. He previously served on the board of directors of the National Comprehensive Cancer Network (NCCN) and has served on the editorial board of several orthopaedic journals, including the Journal of the National Comprehensive Cancer Network and the Cancer Control Journal.
